Athlete Code of Conduct

- 5. The Athlete will agree to conduct themselves according to the international standards as set forth in the FIS governing body collateral or International Ski Federation and Snow Australia (as applicable) rules for conduct. Athletes are responsible for their knowledge of all rules and regulations or the acquisition of such knowledge prior to their travels or attendance and participation in international race events.
- 6. All Australian athletes are required to have an appropriate Snow Australia membership for international racing and adhere to all relevant Snow Australia guidelines and code of conduct. These details are all available from the Snow Australia website including the member protection policy here.

- 7. All expectations related to the respective laws and ordinances relative to any country or province area travelled to, are the sole responsibility of the Athlete, who will be expected to educate themselves and adhere to such expectations and assume their own risk and or responsibility as it relates to the public safety measures associated with breaking related laws and ordinances which are subject to the frequent changes as set forth by associated authority. Fastride Snow assumes no responsibility for an Athlete's adherence to such laws and or local ordinances.
- 8. The use, consumption and/or possession of any unauthorised drugs, including illegal drugs and/or recreational drugs, is prohibited. This is a zero tolerance offence and illegal act.
- 9. The use, consumption and/or possession of alcohol and/or cigarettes/vapes is prohibited during the Fastride Snow program. This is a zero tolerance offence and an illegal act for minors.
- 10. All applicable rules set by the snow resorts are for the safety and well-being of all patrons and will be adhered to and respected. Athletes agree that personal snow sports safety equipment must be worn at all times during program training and competitions.
- 11. Aggressive or offensive behaviour, along with any form of sexual conduct is inappropriate and will not be tolerated. Athletes are expected to be courteous and polite at all times towards athletes, coaches and other personnel and officials.
- 12. Over the duration of the program it is expected that athletes staying in the shared program accommodation will assist with a fair share of household duties such as food preparation for group meals, cleaning and maintaining acceptable standards of hygiene at all times.
- 13. In the event of any breach of this code by an Athlete, Fastride Snow or Fastride Snow employees may immediately contact my parents/guardian to inform them of the breach. Fastride Snow has the right to take action at its discretion. Action may include temporary suspension of passes, exclusion from the program activities or expulsion from the program altogether in which case the Athlete will be sent home on the first available flight at the Athletes expense.

- 15. All participants/persons attending Fastride Snow programs must have travel and competition insurance that covers all travel and snowsports activities including terrain park usage, racing and competitions in accordance with Snow Australia and FIS guidelines. Insurance is a Snow Australia requirement for all athletes competing in FIS sanctioned event and all entries must be submitted via the Snow Australia international competition EOI process.

Liability

16. The sole responsibility for undertaking activities included on Fastride Snow programs lies with the participant and/or legal guardians. By accepting the terms and signing this contract the athlete and legal guardian acknowledge and understand the inherent dangers associated with snowsports and releases Fastride Snow of any liability obligations.

Liability Release

Fastride Snow is a business owned and operated by Peter Baff who is also noted as an indemnified person, pursuant to this release. By signing this contract, certain legal rights will be waived, including the right to sue.

- 17. The undersigned parent/guardian has full legal responsibility for decisions regarding the minor child/ward (if applicable); and
- 18. The athlete and parent/guardian realise that the activities offered, including snowboarding and travel to, from and within the locations provided by Fastride Snow involve risks, which may result in property damage or loss and serious or fatal injury. athlete and parent/guardian acknowledge that terrain parks, rocks, cliffs, cornices, avalanches, changing snow conditions or mechanical failure are an ever-present hazard when snowboarding. The parent/guardian and athlete is familiar with and accept there are risks associated with participation in other activities offered by Fastride Snow including swimming, trampolining, gym training and any other program activities; and
- 19. The athlete and parent/guardian understand that all applicable rules and laws must be followed and that at all times the sole responsibility for personal safety remains with the athlete; and
